Workshop sessions

On Saturday afternoon, a range of focused workshops will be held in order to allow attendees to get a more detailed insight into topics of interest to them. Each workshop will run twice (at 16:45 and 18:00) so that attendees can take part in their two preferred sessions.

Please find a brief outline of each workshop below.

Building a non-violent movement in East Africa (Kenya, Burundi, Rwanda)

QPSW's *Turning the Tide* project in East Africa aims to spread the idea of achieving social change through active nonviolence by giving citizens and local organisations tools to address conflicts peacefully. Tobias Wellner (QPSW), will discuss what we can learn from African peace activists on how to build a movement for change.

City of Sanctuary - hospitality versus hostility

In this workshop we will look at some of the indicators of the "hostile environment" towards asylum-seekers which is sweeping across Europe, and consider how the British model of "City of Sanctuary" and some of the strategies adopted within this network can provide a counter-balance. Led by David and Barbara Forbes.

Making the case for peacebuilding

QCEA's Peace Programme engages European officials and governments to rethink responses to security challenges in the world. Dilia Zwart and Olivia Caeymaex (QCEA) will lead a discussion on how different sectors of government, such as justice, economy and agriculture, can contribute to building peace.

Migration and human rights in Europe

Sylvain Mossou and Kate McNally (QCEA) will explain the different aspects of QCEA's Human Rights Programme. We will focus on our work to promote alternatives to child immigration detention, and ways for refugees to find safety. We will also explain our recent research on anti-migrant hate speech on European newspaper websites, and ways in which European Friends are working together in practical projects.

Quaker gender and sexual diversity community - helping LGBTQI+ people to thrive

Zemirah Moffat and Rob Francis will introduce the UK's Quaker Gender and Sexual Diversity Community. They will share about their recent event *Finding our Voice*, *Growing our Community*, and consider questions including:

- What do we and other LGBTQI+ people need to be safe and to thrive, and why would an LGBTQI+ person not feel safe in certain parts of Europe?
- How can we support ourselves and other LGBTQI+ people to safely thrive?
- How can we manage differences and conflict within our communities and help prevent polarisation and violence?
- Sanctuary Meetings a project of Quakers in Britain

QPSW's Tim Gee, author of the book *Counterpower: Making Change Happen*, will present QPSW's work on forced migration, including information about Sanctuary Meetings in the UK. What can individual Meetings do to offer sanctuary, regardless of their location - and how does this interact with QPSW's work at the national level?
